## **A COMPLETE WAIVER IS REQUIRED TO PARTICIPATE AT ROCKETKIDS**

In consideration of being allowed to enter into the play center and /or participated in any parties or programs at Rocket Kids, the undersigned, on his or her own behalf of the minor identified below, acknowledges, appreciates and agrees that:

1. – Playgrounds, laser tag and inflatables can be hazardous and dangerous. Activities require strenuous exercise and various degrees of skills and expertise. I understand that these activities can result in serious injury to the person or child. I assume any and all risk and damage or injury while on the Rocket Kids premises.

2. - I am aware of the risk, hazards and danger of personal injury, disability and /or death as a result of participation at Rocket Kids.

3.- In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue Dolce Kiss LLC d/b/a Rocket Kids and its owners, agents, employees, officers, directors, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damage liability ,cost or expenses including attorney's fees which are related to or arise out of or in any way connected to my child's participation or use of the facilities.

If I and/or my child(ren) are injured, I acknowledge that I or my child(ren) may require medical assistance, which I acknowledge will be at my own expense or the expense of my personal insurer(s). I hereby represent and affirm that I have adequate and appropriate insurance to provide coverage for such medical expense. I UNDERSTAND AND AGREE THAT DOLCE KISS LLC D/B/A ROCKET KIDS WILL NOT PAY FOR ANY COST OR EXPENSES INCURRED BY ME IF I AND/OR MY CHILD (REN) ARE INJURED. I UNDERSTAND AND AGREE THAT I AM RELEASING DOLCE KISS LLC D/B/A ROCKET KIDS FOR ANY LOSS ARISING OUT OF ITS NEGLIGENT ACTS OR OMISSIONS. 4.-By the execution of this agreement, it's my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against Dolce Kiss LLC d/b/a Rocket Kids, its owners, agents, employees, officers, directors and /or all other persons or entities acting on its behalf.

5. - I acknowledge that my child's participation in activities at Rocket Kids is strictly voluntary. I hereby certify that I'm over 18 years of age, I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all the above terms and conditions. Prior to signing this agreement I have had an opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risk and waive and release all substantial rights that I may have and possess.

6. - I further grant Rocket Kids the right, without reservation or limitation, to videotape, and/or record me and /or my child(ren) on closed circuit television.

7.- I further grant Rocket Kids the right, without reservation or limitation, to photograph, videotape, and/or record me and/or my child(ren) and to use my or my child(ren)'s name, face, likeness, voice and appearance in connection with exhibitions, publicity, advertising and promotional materials.
